# MEMORANDUM OF UNDERSTANDING

# UNIVERSITAS PANCASAKTI TEGAL JAWA TENGAH- INDONESIA

### 1. PREAMBLE

Recognizing the mutual benefits gained through a collaborative program promoting scholarly activities and better understanding across cultures, **Dong Do University**, located at 60B, Nguyen Huy Tuong, Hanoi., Vietnam and **Universitas Pancasakti Tegal - Indonesia**, located at Jl. Halmahera Km. 01, Mintaragen, Tegal Timur, Kota Tegal-52121, Central Java, Indonesia, enter into this Memorandum of Understanding (MOU) and agree to the following:

### 2. PURPOSE

The purpose of this MOU is to facilitate and promote academic cooperation between **Dong Do University**, **Vietnam** and **Universitas Pancasakti Tegal**, **Indonesia** by collaborating into the following areas:

- 2.1 faculty and student exchange programs,
- 2.2 research training,
- 2.3 conducting joint research and sharing of research outputs,
- 2.4 joint courses and educational programs, and
- 2.5 joint international conferences, seminars and workshops

### 3. FURTHER AGREEMENT

- 3.1 This MOU expresses only the intentions of the Parties. The expressed intentions are not binding and no legally binding obligations are intended to, or do, arise as a consequence of the signing of this MOU. Actions taken by any Party in reliance on this MOU will be at that Party's sole risk.
- 3.2 Specific activities, projects, relevant funding and other matters relating to the implementation of the MOU shall be negotiated and executed under separate binding agreements.
- 3.3 The aforesaid separate binding agreements shall cover:
  - a) the responsibilities of each institution;
  - b) selection and enrolment of students;
  - c) the selection of visiting scholars and postgraduate students;
  - d) research collaboration arrangements;
  - e) financial considerations; and
  - f) any other items necessary for the achievement of the proposal.



## 4. FINANCIAL CONSIDERATIONS

The Parties acknowledge that all or any financial arrangements proposed must be negotiated and will depend upon the availability of funds of each Party.

#### 5. CONFLICTS OF INTEREST

The Parties agree that, as of the date of the signing of this MOU, to the best of their knowledge, no conflict of interest exists or is likely to arise in relation to the intention of the Parties to co-operate under this MOU. If, during the term of this MOU, a conflict or potential conflict of interest arises from one of the Parties, then that Party will immediately notify the other Party in writing of that conflict or potential conflict of interest.

#### 6. TERM OF MEMORANDUM

- 6.1 The term of this MOU shall commence on the date hereinbefore written, for a period of 5 (five) years, and is renewed by the mutual written consent of the Parties unless terminated sooner as provided herein.
- 6.2 Either Party may terminate this MOU with a 90-day prior written notice to the other Party.
- 6.3 This MOU may be amended or varied from time to time provide that such amendment or variation is evidenced in writing and signed by the Parties.

This MOU is written and signed in 2 (two) copies in English having equal force, each Party receiving one copy.
