



MEMORANDUM OF AGREEMENT INTERNATIONAL COLLEGE OF RAJAMANGALA UNIVERSITY OF TECHNOLOGY KRUNGTHEP - THAILAND

AND

FAKULTAS EKONOMI DAN BISNIS UNIVERSITAS PANCASAKTI TEGAL - INDONESIA

Pursuant to the spirit of the cooperative relationship between Fakultas Ekonomi dan Bisnis (FEB), Universitas Pancasakti Tegal (UPS) whose address is in Jl. Halmahera Km. 1, Tegal, Indonesia and International College of Rajamangala University of Technology Krungthep (ICUTK), and within the framework of the existing Memorandum of Understanding.

It is the intention and purpose of this bilateral agreement to provide pertinent information regarding programs of both Institutions.

The purpose of this program is to provide mutual opinion and agreement on:

- (1) Credit Transfer Program
- (2) Sit In Program
- (3) Joint Publication
- (4) Joint Conference
- (5) International Field Study (KKL Internasional), Internship Program (Program Magang Internasional) and International Students Community Service (KKN Internasional), and
- (6) Shared Learning Program.

ICUTK acts as a host university and Fakultas Ekonomi (FE), Universitas Pancasakti Tegal (UPS) whose address is in Jl. Halmahera Km. 1, Tegal, Indonesia as a home university.

The conditions are as follows:

- a. Host university will provide pertinent information of the programs and study plans for the eligible exchange postgraduate students.
- b. Registration fee / student to ICUTK is 3000 baht per person including:
 - 1) Certificate
 - 2) Letters of Acceptance (L.O.A) / Letter of Invitation

and excluding:

- 1) Pick up and drop service to the airport
- 2) Hotel
- 3) Meals
- 4) Coffee break
- 5) Other activities
- c. The topic and sub-topics of topics will be determined by both parties
- d. The host university will provide certificate for learning.
- e. Non facilities of student insurance

- f. Students must agree to comply with the host university's policies and regulations regarding admission, maintenance of student status, and code of behavior.
- g. Duration of the Memorandum
 - 1. This agreement will become effective upon the signature by representatives of the two parties and shall be in effect following the validity period of the M.O.A that has been signed.
 - 2. Amendments to this Memorandum of Agreement will only be made by the agreement of both Parties.

It is through this mutually respectful endeavor that we look forward to a successful realization of these aims, which by the signatures below, shall come into effect for immediate implementation

"SHARE LEARNING"

The purpose and objective of this program:

- i. Share learning is additional learning, to increase the human resources of students to gain International insights and different conditions and situations
- ii. Students follow the additional lectures of international standard education.
- iii. Students study some topics in ICUTK Thailand based on their schedule and then continue to study on their respective campus in Indonesia.
- iv. The students study with the equivalent of 4 meetings in the classroom on their respective campus in Indonesia.
- v. Cause of the course has the same topic, need for coordinating with the lecturer of origin.
- vi. Student study a full day's study from morning to afternoon, based on applicable hours, it's 8 hours / day
- vii. The lecturer here only, teaches as additional lecturer, the main lecturer is not replaced
- viii. Lecturer in IC-UTK provides course materials
 - ix. Assignments, Mid-term or final exams can be undertaken in IC-UTK Thailand
 - x. The final score is decided by the home lecturer.
- xi. The certificate is issued by host university (IC-UTK) with 2 logo be used in the certificates.
