

## MEMORANDUM OF AGREEMENT Faculty of Law Prince of Songkla University (PSU Law) Thailand

and

## Faculty of Law, Universitas Pancasakti Tegal (UPS Tegal) Indonesia



This Memorandum of Agreement (MoA) is intended to implement the programs as stated in the the Memorandum of Understanding between the Faculty of Law, Prince of Songkla University Thailand, hereinafter shall be referred to as "PSU Law" and the Faculty of Law, Universitas Pancasakti Tegal, Indonesia, hereinafter shall be referred to as "UPS Tegal." The purpose is to provide mutual opinion and agreement on students' mobility (Sit-in Program) where PSU Law acts as a host university and UPS Tegal acts as home university.

Both PSU Law and UPS Tegal have come to an agreement to organize the Sit-in Program under the following circumstances:

- a. The home university shall send students to the host university with the duration of no longer than 29 days.
- b. The host university shall provide the following for the program:
  - 1) Certificate
  - 2) Academic performance report
  - 3) Cultural Study and/or Cultural Tour
  - 4) Field study related to the disciplines if possible and applicable
  - 5) Letters of Acceptance (L.O.A)
  - Pick-up and drop-off service for the students to and from the host university airport

The host university shall not be responsible for the following:

- 1) Meals and stipends
- Travel expenses to and from the home country.
- 3) Insurance
- 4) Accommodation
- c. The minimum number of students is two (2).
- d. The courses selection to attend in the classroom for the students will be determined by both parties
- e. The host university shall be in charge of all activities of the students from home university for the entire duration of the program.
